TOWN HALL RECAP

OAS held three town hall sessions on September 14.

The Pillar Ambassador Team began by announcing a few significant changes:

- To better reflect their purpose as a team, they have changed their name to **Employee Engagement Team**.
- The Town Halls are moving from a quarterly to a bi-annual schedule.
- Excellence Award Nominations will no longer be graded according to their "Wow Factor" alone, but also on the basis of the nominee's commitment and reliability.

The team also presented OAS Scholarships and Excellence Awards and did several raffle drawings throughout the presentation!

Following the Employee Engagement Team, USF's Chief Human Resources Officer, Angie Sklenka, introduced herself and encouraged OAS employees to recognize themselves as leaders and harvest the most out of their work every day. Then, Hari Patel and Scot Berrian discussed the deferred building maintenance program and announced that USF received a total capital renewal of \$72.8M to improve the university's infrastructure. Next, Bill Land did an overview of EHS training changes, walked us through the transition to online training, and reminded us how the latter is crucial to ensure everyone is safe, healthy, and compliant. Jim Neighbours presented the new Interactive Campus Map application (which can be found at gis.usf.edu) and Rob Marlowe discussed the Active Threat Response Training.

VP Carole Post then discussed how we have progressed in the past six months and what lies ahead. She addressed compensation priorities and retention initiatives including a three-tier advancement path within some positions, giving people opportunities to advance within their roles. At the end of the Town Hall, there was also a Q&A in which VP Post answered employee questions.
