Florida Policy Survey: Higher Education Supplement

Summary: Researchers at the University of South Florida conducted a statewide survey of 600 Floridians to measure public opinion on a variety of current policy issues. The result presented in this report address attitudes toward higher education and student loan debt. The survey included a representative sample of Floridians, fielded between July 15th and 25th, 2021. Topline results are reported below with a confidence level of 95% and a margin of error +/- 4.

Key Findings:

- Two-thirds of Floridians (67%) favor an extension of the pause on student loan repayments that was initiated in response to the COVID-19 pandemic.
- Most Floridians (61%) either somewhat or strongly agree that a college education is necessary in order to succeed in America today.
- Just over 70% of respondents agree that a college education should be considered a "basic right" for all Americans.
- Nearly two-thirds (64%) say that greater investments in higher education are necessary to overcome historic racial inequities.
- An overwhelming majority of Floridians (85%) say that greater investments in higher education are necessary in order for America to remain competitive in the global economy.
- There is majority support among Floridians for providing free tuition to students attending community colleges (66%) and public universities (60%).
- A majority (61%) also support recent proposals to forgive up to \$10,000 in student loan debt for all borrowers. Support declines for greater levels of forgiveness: 50% support forgiving up to \$50,000 in debt, while 46% support forgiving all outstanding student loan debt.



Summary of Responses

The federal government has placed a pause on the repayment of federal student loans during the COVID-19 pandemic. This is set to expire at the end of September. **Do you believe that the repayment pause should be extended?**

Survey Information

600 adult Floridians were surveyed via an online web-panel using Prodege MR, an industry leading market research provider. The survey was fielded from July 15th through 25th, and the results are reported with a 95% confidence level and a margin of error of +/- 4. Respondents were selected via a stratified, quota sampling approach to ensure a representative sample. Quotas for gender, age, race/ethnicity and party affiliation were determined based on data from the U.S. Census Bureau, Florida's Department of State, and Florida's Office of Economic and Demographic Research (EDR). Quotas were stratified by region of the state to ensure geographical representativeness.
