The contract provides imaging services through TGH Imaging (Tower Radiology LLC) for USF Health's fMRI Research Core, including access to a GE 3T MRI Scanner, certified MRI Technologists, and patient scheduling. These services ensure compliance with IRB protocols and research standards. The scanner supports investigational sequences critical for data integrity, while on-site staff enable contract administration and emergency support.

In your own words, describe the reason(s) the item is not subject to competition from other sources and how the stated specification(s) restrict the requisition to only one supplier. TGH Imaging functions as the staffing and operations partner for USF Health's GE 3T MRI scanner, providing certified MRI technologists, patient scheduling, and contrast administration under physician oversight. Their support ensures compliance with research protocols and clinical safety standards. No other vendor offers the integrated staffing, oversight, and operational infrastructure necessary to support the research-specific use of USF Health's FMRI facility.

In your own words, describe the due diligence conducted to validate this supplier as Single Source. Due diligence included reviewing other regional imaging provides such as Radiology Associates of Florida and SimonMed. However, none could provide the integrated staffing, contrast capabilities, or compliance infrastructure required to support research on USF Health's MRI system. Additionally, TGH Imaging is the preferred provider under the existing contractual relationship between USF Health and TGH as part of a conjoined academic medical group, further supporting their designation as the sole qualified source.
