Meeting Called to Order at 3:02 p.m. (EST).

1. Welcome and Announcements

Adriana welcomed the council members to another Undergraduate Council meeting.

2. Approval of November 25, 2024 Undergraduate Council Meeting Minutes

The minutes were approved (no revisions).

3. Informational Items

1. Quality Enhancement Plan – Addye Buckley-Burnell

Dr Buckley-Burnell, the Associate Vice President & Executive Director Center for Career & Professional Development, gave a presentation about this year's Quality Enhancement Plan (QEP). It is titled *ExCeL*, short for Experiential Centered Learning. The goal for ExCeL is to ensure students are career-ready come graduation by expanding meaningful experiential learning opportunities.

In addition to traditional co-ops and internships, access to employment and undergraduate research are to be expanded as they are the High Impact Practices that align with student engagement, retention, and first-destination outcomes (e.g. graduate school, full-time employment, median salary). All students will not be siphoned into the same experience; rather the goal is to provide students with a better concept of their post-graduation career goals and experiences will be aligned accordingly.

Ultimately, ExCeL would like to aid students in Identifying and Evaluating experiential learning opportunities that match their interests, while also giving them the tools to effectively Demonstrate and Communicate career readiness competencies acquired through courses and experiences. Therefore, a mandatory career module has been launched for all first-year students at the university. This will inform students about various aspects of the career cycle, such as how to choose a major and what experiences will align with their chosen program. These modules will be updated with additional topics (e.g. resume-building) into the Spring and Fall semesters.

A Faculty Champion Program has been established to strengthen the partnership between faculty and the Center for Career & Professional Development. Faculty will be trained in the career development cycle in assurance that these resources will be embedded into their courses. A stipend will be provided for those who participate and at the end of the year a recognition ceremony will be held to laud those who exemplify the ExCeL mission.

New funding opportunities are also being created by leveraging Federal Work Study (FWS) funds and grants for both on and off-campus experiences.

Dr Buckley-Burnell charges the council with keeping the ExCeL QEP in mind for student experience tracking. Posters will be placed around campus (and are available online) for students to upload their experiences into Handshake, thereby providing helpful data for the Career & Professional Development team. She also entreats council members to be aware of any potential on-campus internships they may be able to create that are eligible for FWS funding. Lastly, she asks for faculty to assist in assessing student outcomes by way of Canvas Outcomes. This can be done by adding pre-made elements to rubrics and question banks. There is no reporting-out from faculty; once the elements have been included, data is automatically sent to the Career & Professional Development team. The goal is to have a better understanding of what students are accomplishing in their courses directly from the source.

3. Agenda Roundtable Discussion

Council members and guests discussed their preferences regarding the layout of the Consent Agenda. Previously, items were simply listed without description. Going forward, items will be accompanied by a summary describing the changes that have been requested in each proposal.

4. Consent Items (All Effective 25-26) – ALL APPROVED

1. Accountancy and Analytics B.S.

(Requests removal of "Behavioral Science or Humanities Course" and "Ethics or Political Science Course" requirements from the Accountancy and Analytics Required Courses core. This grants students more electives that are tailored to their interests while also aligning LPSOA with other programs in the college.)

2. ACG 3113 – Intermediate Financial Accounting II

(Requests change to description and removal of two prerequisites, ACG 3401 – Accounting Information Systems and TAX 4001 – Concepts of Federal Income Taxation. The latter aligns the course with recent requisite updates to ACG 3103 – Intermediate Financial Accounting I, where these two courses were removed as corequisites.)

3. APK 3120 – Exercise Physiology

(Requests change to course objectives, outcomes, and/or major topics.)

4. APK 4138C – Applications of Strength and Conditioning

(Requests change to course type, requisites, course objectives/outcomes/major topics to align with the new Exercise Science and Kinesiology B.S. concentration that will focus exclusively on Strength and Conditioning.)

5. Athletic Coaching Minor

(Requests replacement of APK 3120 - Exercise Physiology with PET 4380 - Applied Exercise Science as changes to APK 3120's learning outcomes and modality made it more suitable for clinical, rather than educational, settings.)

6. Business Foundation Core – PHI 1103 inclusion (all Muma programs affected excepting Hospitality Management B.S.)

(Requests addition of PHI 1103 - Critical Thinking as a required non-business elective for all business majors.)

7. Business Foundation Core – SCM 3005 inclusion (all Muma programs affected excepting Hospitality Management B.S.)

(Requests swap of MAN 4504 – Operations and Supply Chain Management with SCM 3005 – Supply Chain Management in Muma core. This will provide all students with introductory knowledge of supply chain functions while mitigating advising challenges that come with a 4000-level course.)

8. Business Foundation Core – International Business course inclusion (all Muma programs affected excepting Hospitality Management B.S.)

(Requests addition of an international business course for students who do not satisfy the Study Abroad requirement.)

9. Chemical Engineering B.S.C.H.

(Requests removal of BCH 3053 and CHM 2211 as content in these courses are not necessary for students, nor are they prerequisites for any additional B.S.C.H. coursework. The removal of three general elective credit hours will reduce degree hours from 131 to 125.)

10. EEE 4359 – Analog CMOS/VLSI Design

(Requests removal of corequisite, EEE 4301 – Electronics II, as its contents are now covered in EEE 4359.)

11. EEL 4461 – Antenna Theory

(Requests removal of an unnecessary prerequisite, EEL 4423C – Electrical Circuits & Systems Design Laboratory. The course will now have one requisite, EEL 3472C – Electrical Engineering Science II - Electromagnetics.)

12. Entrepreneurship B.S.

(Requests addition of new course: ENT 4933 – Selected Topics in Entrepreneurship to required courses.)

13. ESE 4341 – Secondary Teaching Methods

(Requests changes to schedule type/delivery mode, textbooks; course objectives, learning outcomes, and/or major topics. Due to the Textbook Affordability program, ESE 4341's textbook will be changed to a newer and less expensive option.)

14. General Business Studies B.S.

(Requests inclusion of "Supply Chain" and "Risk Management" as two additional areas of focus for degree. This will enhance student success by granting new options tailored more towards students' interests.)

15. Global Business B.A., with Business Analytics and Information Studies Concentration

(Requests replacement of ISM 4382 – Global Information Systems with ISM 4041 – Global Cyber Ethics as a required concentration course as ISM 4382 has been discontinued.)

(Requests change to program description to account for previously approved Health Sciences revisions to course composition, concentration hours, and degree hours.)

(Requests complete revamp of Marketing core to align with new the two new Marketing degree programs. The new core will ensure students have knowledge in the latest business trends and technologies, such as artificial intelligence and Account Based Marketing.)

(Requests MCB 3020L corequisite removal due to advising challenges that would not allow students who had not taken the lab to register for the lecture.)
