Meeting Called to Order at 3:00 p.m. (EST).

1. Welcome and Announcements

Adriana welcomed the council members to another Undergraduate Council meeting.

2. Approval of January 27, 2025 Undergraduate Council Meeting Minutes The minutes were approved (no revisions).

3. Informational Items

1. Course Objectives Guidelines – Dr Derek Wildman

Dr Wildman, chair of the Graduate Curriculum Committee, expressed his concern to the council regarding the vast increase in course objectives listed on course syllabi and proposals in the past few years. He notes that many courses have upwards of twenty to thirty objectives, dividing out to more than one objective per week. While he understands the rationale for listing these many objectives, he and his colleagues believe this can cause several problems for the course going forward. One being that a high number of objectives can dilute the educational message of any given course; and two, it constrains faculty in what they can or cannot teach in a particular course. The latter, Dr Wildman explains, is particularly problematic in cases where a course may need to be taught by an individual other than its main instructor. If a course has thirty objectives, the

substitute faculty member may not have the expertise to handle all thirty objectives. He recommends holding steady with a broader list of objectives that allows for greater flexibility while also staying true with the goals of the course.

The Graduate Curriculum Committee, with guidance from Carol Hines-Cobb and Joseph Butts from graduate administration, have devised the following language that has been approved and adopted by the Graduate Council:

"The optimal number of course objectives and learning outcomes is four to five each. Objectives should be broad enough to cover a few weeks of content. Learning outcomes should be measurable and directly align with the objectives. Should you need a greater number of objectives/learning outcomes, contact OGS for guidance."

Dr Wildman understands, due to accreditation and other college-based requirements, five objectives may not be suitable for every course, but he provides the above language as a recommendation for the Undergraduate Council.

The guides for Course Objectives and Learning Outcomes that the Graduate Council approved have been noted on the Office of Graduate Studies website. This item was not brought to a vote for Undergraduate Council, but Dr Uruena-Agnes intends to broach the subject in future once the council has had time to consider the change in guidelines.

2. General Review of Council Procedures, Council Resource Sheet and Vote – Adriana Uruena-Agnes

With guidance from Dr R. Oscar Bernard, former Undergraduate Council chair, and Dr Kyna Betancourt from Undergraduate Studies, four edits were made to the 2024 version of the UGC Reference Guide. In brief, these changes are to

- council attendance: council members unable to attend the meetings shall
 offer substitutes from their own areas or disciplines; excepting special
 circumstances, the Chair may issue a substitute (without notification) for any
 council member who fails to attend more than two meetings in a calendar
 year)
- 2. **proposal assignments:** councilmembers with conflicts of interest towards any given proposal(s) may not accept the proposal(s) for review, nor can proposers review proposals of their own origination. Also, if there are issues with the proposal that the reviewer believes the proposer is unable to resolve, the reviewer will contact the Chair to explain the reasons for these concerns before the meeting. If a council member decides to make a motion not to approve a proposal, the reviewer will inform the Chair before the meeting.

A syllabi checklist for reviewers was also included.

These inclusions were brought to a vote and approved unanimously.

3. Five-Year Course Discontinues (65 Total) – Mary Collins

Mary Collins, assistant director of curriculum and functional technology for Undergraduate Studies, brought a list of sixty-five courses that will be discontinued effective the 25-26 academic year. Overall, 162 courses were found to be inactive within a five-year timeframe. This list was sent to the various colleges for review with fifty-seven chosen to remain with reinstation for spring, summer, or fall 2025. Forty courses were retained due to extenuating circumstances such as the benefit of the Education Abroad program or college-specific reasons. The remaining sixty-five courses were approved for discontinue as the colleges have no plans to teach them within the next five years.
